SUPPLEMENTAL INTERROGATORY RESPONSES AND  
DESIGNATION OF A RULE 30(B)(6) DEPONENT**

Defendant NCR Corporation ("NCR") moved the Court on August 8, 2014 for an order compelling Defendant International Paper Company ("International Paper") to supplement its interrogatory responses and to designate a Rule 30(b)(6) deponent (the "Motion") [Doc #531]. Pursuant to the Court's August 15, 2014 Order Referring Motion to Compel, Judge Robert J. Jonker referred the Motion to Magistrate Judge Hugh W. Brenneman, Jr. pursuant to 28 U.S.C. 636(b)(1)(A). Further, pursuant to Local Rule 7.3(c), International Paper has until Monday, August 25, 2014, to respond to the Motion.

NCR and International Paper have been engaged in ongoing discussions to either resolve or narrow the issues in dispute relating to NCR's Motion without Court intervention and, in

connection with those efforts, NCR has agreed to extend the time for International Paper to respond to the Motion by fourteen days, to September 8, 2014.

NCR and International Paper hereby stipulate that the time for International Paper to respond to NCR's Motion be extended to September 8, 2014
