Upon conviction of the offense charged in this Indictment, the defendant,

ROBERT THOMAS CARLSON,

shall forfeit to the United States pursuant to 18 U.S.C. § 2253(a), any visual depictions described

in 18 U.S.C. § 2252A; and any book, magazine, periodical, film, videotape, or other matter

which contains any such visual depiction, which was produced, transported, mailed, shipped or

received in violation of § 2252A; and all property, real or personal, used or intended to be used

to commit or to promote the commission of violations of § 2252A, including but not limited to

the following:

1. Personal Property

a. One Gateway model M-1625 laptop computer, serial number GWTC8120FQX;

and

b. a 250 GB Western Digital hard drive, serial number WXC108D09035.

2. If any of the property described above, as a result of any act or omission of the defendant:

a. cannot be located upon the exercise of due diligence;

b. has been transferred or sold to, or deposited with, a third party;

c. has been placed beyond the jurisdiction of the court;

d. has been substantially diminished in value; or

e. has been commingled with other property which cannot be divided without

difficulty,

the United States of America shall be entitled to forfeiture of substitute property pursuant to Title

21, United States Code, Section 853(p), as incorporated by Title 18, United States Code, Section

2253(b) and Title 28, United States Code, Section 2461(c).
