PRISONER'S TESTIMONY AT HEARING: At the hearing the prisoner stated, "Not guilty. He gave me my tray and picked up my tray. How many officers will take a chance and pick up a tray if he was threatened? At no time did the officer make me kneel on the bed and get another officer to pick up the tray." He doesn't know this guy. The officer told him that he heard about him from Perala. "This officer looks like a brand new officer out of the academy." He just told the officer that he needed to wear a hair net. The officer came back and took his tray, hand to hand. He wouldn't have done that if the officer had just been threatened. When asked if he had anything to add to his written statement, the prisoner responded, "Naw, I'm not guilty. You going to do what you want to. If I was going to do something to him, I wouldn't tell him and I would just do it when I went to GP. I don't even know nothing about him. He told me that he heard about me from Perala. I told the officer that he looks like he is fresh out of the academy and he should wear a hair net and then he writes me a ticket for that?" Prisoner informed of the decision and sanction prior to leaving the hearings room.

REASONS FOR FINDINGS Continued from Page One:

THREAT: On 4/7/17 the prisoner stated to the officer, "Wait till I get to GP, white boy, I'm going to get your ass." This expressed the intent to physically assault the officer. Prisoner intended to cause fear of physical harm in the officer as the prisoner directed his threat to the officer when the officer came to the prisoner's cell door. Prisoner claims that the officer, who appeared to be a "brand new officer out of the academy" became verbally abusive to him when the prisoner told him to wear a hair net and then the officer did not take proper precautions when he later picked up the prisoner's tray. Prisoner is not believed that he didn't threaten the officer. First, the fact that the officer didn't have another officer with him when he later picked up trays proves little when the officer may have believed that the prisoner would not carry through on his threat. It also could be a case of the officer not knowing better because he is a "brand new officer." Second, prisoner's complaints about the officer sounded more in justification for a threat than actual denial. Third, as pointed out by the prisoner, it would make little sense for the officer to pull this out of thin air because the prisoner told the officer he should wear a hair net. Reporting staff member factual and is credible as to what occurred. Prisoner's statement, if anything, gave context for the threat. Charge upheld.

<p>Oral by prisoner at hearing: not guilty. They gave me a duffle bag and moved me 9 days before to his wing. I have problems with him. He said he was going to set me up. He took the first tray and then threw the second tray and jumped back to make it look like I did. It is his word against mine.</p> <p>The investigation was read to and reviewed with the prisoner; it included: 5 pgs. The H.I. and prisoner's statements. The grievance would not tell me if the report is or is not true.</p> <p>Video seen outside the prisoner's presence; it is held confidential as to show prisoner would allow him to know the ability of fixed mounted surveillance cameras and compromise security. Summary of video also confidential.</p> <p>The prisoner had nothing to add.</p> <p>The prisoner was then told findings and issued a sanction. The report was then typed outside the prisoner's presence. The hearing was conducted via Tele-video conferencing with the hearing officer in Marquette.</p>				
REASONS FOR FINDINGS				
<p>Assault and Battery (008) 03.03.105A (staff victim) Intentional, non-consensual touching of another person done either in anger or for the purpose of abusing or injuring another; I find the prisoner is guilty of the charge. The prisoner indicated in his statement and at hearing that he and the officer did not get along. In fact he said he had grieved the officer. That would not tell me the officer set him up or made this up. It is just as likely that the prisoner would threaten or assault and batter the officer. It is not likely or persuasive that the officer would tell the prisoner he was going to set him up and then wait days to do so. It is not likely that the officer would attempt to set up the prisoner by claiming an assault and battery which is captured on camera as this was. The video is consistent with the officer's version, not the prisoner's. The officer was collecting trays and after taking the first one the prisoner threw the second one out of the slot and it struck the officer in the leg. This was a deliberate and intentional action as the prisoner also said "I told you I was going to get your trailer park ass one of these days." The prisoner would likely tell the officer this as he made non-consensual contact with the officer with the tray. This was deliberate and intentional and done in anger as indicated by his comment to the officer.</p>
