(Introduction)

This is to tell you a little about myself and what the Paper work entails! I was diagnosed dyslexia in 3rd grade. I no longer write backwards, However my Spelling Suffers! I am having someone edit my Spelling. Doing this is a very big deal for me! It has been very Challenging Not only due to my dyslexia, depression, and O.C.D! I Tend to Copy and Recopy then I am Battling Sanctions So it's hard to get help to go Places, I need to go; it adds to Anxiety and depressions. I am doing my best, I hope you can Read and understand what I am saying!

I have been going Law Library about a year now. I am by far not stupid. I am Pretty well spoken, I Read and understand well! I do not claim to know it all or claim too. I am open to suggestions. I WAS very surprised how much there is to Law! It has given me a New found Respect for LawMakers, Judges and Lawyers! Not to mention all the different facets of Law. I can only imagine the extent of the Education it takes ~~and~~ to make and enforce the Law! My Law library time seems to be alot too me. No one taught me anything Being on Sanctions; I can not talk to anyone! The Law Library there is no talking, I just Research and take notes and Learn! I just want to say thanks for Being their when Life, Liberty, and Justice is Compromised.

There is a quite a bit to explain. This has taking place over 15 months! I will make this as brief and to the point as possible. I will only mention ~~these~~ the most apparent facts now! There is more.

Through Research I have found operating Procedures from Prison to Prison may vary slightly, but never trump Prison Policy, Prison Policy never trumps State Law; State Law never trumps State or Federal Constitution! URF seems to think they trump them all! and why not, they do not get in trouble for what they do, so they keep doing it and get better and better at it Corruption Runs so deep, you can see it, this has been going on for quite some time. They do know how to stick it to you and dance around it! When Inmates use Administrative Remedies they spin and shoot you down so much you give up! Then they ticket you heavier and you spend months on Sanctions. I spent Every bit of 14 Months on Sanctions! And they keep you on Sanctions as well. I will Prove what I say, I have documents, Kites, ~~logs~~ Log's, times and dates to back me up. I will only speak on myself as that is all I can do!

I will reveal all I say! oh yeah, and I got thrown to the Pavement face first on a cold day just because my Cuff's were too tight. Believe me, you will be in awwww just as I am, I am a L Prefix and never, ever seen this type of activity or have been mistreated at any Prison!

I may be a Prisoner, However, I am a Person first.

I Rode into URF on 9/17/16. This all started on 10/7/16 at 6:30 p.m. PAGE 1
 in the chowhall. I Lawrence Dallas #314685. I was eating a sandwich, I see
 the C/O's were clearing the chowhall. I figure I would eat the
 sandwich on the walk, so they could clear the chowhall faster, I
 never had any problems doing this in the past at other facilities!
 URF has their own rules and they are subject with emotion like
 the wind. I was just trying to make their job easier to get the
 chowhall cleared quicker, a C/O said "throw the sandwich away!" Kids are starvin'
 (Right?) and in Prison food means shit! It is all we have. I was upset in my mind
 I was just trying to help them get their job done quicker, I did
 fully comply with the C/O's order. I did have a little bit of an
 attitude. It by far was not a big attitude, there wasn't any swearing
 or blowing up, just a bit rebellious. I threw the sandwich away, done and over
 with, I started to walk back to the unit, Sergeant Davidson says "go to control center
 I am already thinking for what? this is no big deal, it's done and over! It's just a
 sandwich! He gets to control center with a big mean look on his face
 like he wants to kill me. I asked him not out of tone, or angrily. I
 said "why are you looking at me like that?" "you're making a big deal out
 of nothing!" He said "you want to see a big deal"? He waves the C/O's over, they
 cuff me up and take me to the hole. The ticket reads threatening behavior! He
 may veins were sticking out of my neck, and I told him I would
 make this a big deal, none of which was true, I swear!
 Being's that the ticket said this, I told the hearing investigator I
 wanted to see and use the video footage as evidence. When I
 got to my hearing, there was no video. Now this was in front of
 the control center, where you come and go in and outside of Prison
 cameras are all over, it is the most secure spot in the Prison!
 I found out later that if there is no video, the ticket has to
 be dismissed, it says so in the hearing's handbook! I was not
 legal savvy at all at this point. I did not know that my due
 process rights, I was found guilty. If there was a threat,
 they would have to prove it. there wasn't any threat at all!
 The place where we were, there was video. by me requesting
 for the video; they should have not found me guilty; if they
 could not produce the video, I knew something was wrong, I
 had to start and learn my rights quick or I was in for it. This was the
 start of a long list of violations, Prison Policy, State Laws, and Constitutional
 Law Violations! There was harassment, sanctions, and finally excessive
 force that leads to a breakdown that leads me to be hospitalized for
 treatment!

I do feel sorry for other inmates at URF. They have the same raged kind of opportunity as I do too attend the Law Library and learn and be diligent. Believe what I say. This is probably hard to swallow, as it was for me! I have dates to back me up and prove to you that I am not lying. I have about 40 tickets, around 4 grievances, and Kites where I have been harassed and spun like a top. I had to learn the process, I never had any sort of problems on my A and B Prefixes, on my A Prefix I did 3 years I may have received 8 tickets on my B Prefix, I think 2 tickets in 18 months. All this should be in my file! I am being generous at 10 tickets in 55 months. I am older and more laid back and I got at least 40 tickets in 9 months at URF. The reason I say this took place in over 15 months, when I went to WCC and ECF where I am currently at now! I still had sanctions and hearings to attend. I just want to assure you I am giving the best and accurate information as I know it to be. Being creditable is what I hope will lead me to my victory! Anyway 40 tickets over 9 months is just blatant harassment! I am sure I deserved a few of them. I am not perfect, I am trying to be better, this is all I can do. I may deserve 10 but not 40; this is in no way helping me or correcting me at all! It is just keeping me from my family, getting a job, being social, working out and my mental health suffers as well! If you can't trust a state worker who you can trust, this is supposed to be the Department of Corrections! Most facilities are OK and the C/O's are OK as well, just URF is corrupt!

Now back to some facts, after the sandwich incident things got a lot worse, I was getting ticket after ticket. Things that would mark a verbal warning, like using the rest room at 3:00 a.m. without permission and half asleep, on top lock you have to get permission to use the rest room! I would ask to use the rest room during the day, the C/O's would say "No"! I would talk them "I have been drinking coffee, may I please use the rest room"? they would tell me to pee in my pants! I would say tell them "write the ticket, I have to go!" This happened to a couple other's. Not just with me being denied to use the bathroom. Oh yeah, there was this one lieutenant, his name is Watkins, I am trying to speak on C/O's with rank, just to give you an idea! This lieutenant was bad, no respect at all. He would look at his watch and tap it like, hurry up! I laugh at first, then it just got kind of sickening, time after time. He would tell me, I can predict you're future Mr. Dallas, you will be in level 4 or the hole soon! I did not even do anything. Why would you tell a guy that? One day he said "I know all about you Mr. Dallas. Another day, he told a lady C/O that is Dallas. I did not hear the rest, now this was a big one, I even have a witness! My Bunkie at the time, WILLSON 587657

He was a ~~little~~ ^{little} ~~person~~ ^{person} Someone. Willson said he saw Watkins Point at me and say he will be in the hole soon! This was A training C/O. They train C/O's to be Bad C/O's. their, And No only that, but they talk, and if they do not like you they tell other C/O's, then they mess with you so it's not harassment, they have it down too a science there! All these tickets and sanctions were building up, I could not believe it I would do 30 days and get 5 more days of sanctions. It was missing with me Bad. I was like, am I that bad? What is going on? page 2

On 11/18/16 I was receiving a tattoo; I am not Perfect as I said. I deserved the ticket! Prisoner Anderson 165773 was giving me a tattoo and was already on NON-Bond for giving a tattoo to another inmate. Non-Bond is Pretty Serious Business! you are to leave your room, except for chow and you have to get a signed Pass to eat! we went to our hearing at the same time, it was only my ~~2~~ Second CLASS one ticket. Anderson got 30 day's L.O.P! I got 30 L.O.P and 3: Toplock, I got more time than him, and he was ON NON-Bond Status and giving the tattoo! That's when I woke up, I know I was for sure aware and knew that something was wrong. I knew that Sergeant Davidson and other C/O's were talking about me to make my life hard, when you receive a class one ticket, it is posted in the C/O's Lounge Room! They were doing a good job of Singling me out and harassing me. I had months of sanctions at this point, then 11/16/16 out of Place, 11/18/16 out of Place, 11/24/16 out of Place, 11/25/16 violation of Posted Rule, 11/25/16 out of Place, 11/30/16 out of Place, 12/3/16 out of Place, 12/6/16 out of Place, 12/8/16 2 out of Place tickets, the third ticket was an Insolence. I deserved that one, I had asked the C/O if I could ask the Counselor to use the Phone. I had not used the Phone in forever, he said no; I was stressed from all the tickets, and No Phone calls, and Holidays! you see I was getting tickets Almost every day. I could not even knock days out. I would do 1 or 2 days and get 7 more, it was very frustrating. I went off and finally told him too fuck off and all that good stuff! I just wanted to get on the Phone and talk to my girl, we were on the Rocks as it was due to lack of communication. I had not been back to Prison long at all. The tickets were flying, I began to cut myself, I could no longer take the stress. I tried to be good, the more I got tickets. I could not understand it! C/O Russo was searching my room, he had trash in the hallway, I picked it up and threw it away for him! He was like "did you get permission too empty the trash" I said "No." "I was trying to help". He wrote me a ticket on that. Another time I was writing my girl because we couldn't talk, I had one foot on my chair and my butt on the top bunk so I could get down quick and work on my letter. He wrote me an out of Place for that I was on my Bunk, it was stuff like that, I was getting ticket after ticket!

This is where it gets deep. Sergeant Davidson comes to the unit and says you have 3 tickets that I have to review you on. I was like, I did not do anything! He said "well you have 3 tickets here I am going to review you on". I told him, "I couldn't take it any longer. Take me to the hole". I was in a fragile state of mind! I did not act mad; (I was just sick of it all). I was more hurt and disappointed and depressed than anything. Sergeant Davidson tells Conners and Koskela to cuff me up. I did forget if Conners or Koskela cuffed me, I believe it was Conners. We were walking to the hole, Sergeant Davidson is behind us, Conners on my left arm, and Koskela on the other arm. Conners must weigh 340 LB and Koskela 300 LB, they both had a tight grip on each arm, we were in front of Round Unit Level 4. I told them the cuffs were too tight, I could not feel my hands. I asked them to please loosen the cuff. They said "stop resisting". I said "I am not resisting, loosen the cuffs!" they threw me face first to the pavement, and hard! My face was a bloody mess. They said "you should have stopped resisting". In a small way, I said ~~that~~ "I did not resist, the cuffs were too tight". First the cuffs were tight, second I asked to go to the hole. And third the C/O's had me by the very firm, I could not resist even if I wanted to, they both out weighed me by a lot! Michigan Law says law enforcement is only to apply as much force as needed to restore peace and order. I do not see that peace and order disrupted, and if it was, I was already in cuffs! That much force was not needed. They did not have to do that by no means whatsoever! It is excessive force anyway you slice it. I have permanent scarring above and below my eye. I have been diagnosed by the doctor with tinnitus, which I couldn't get a diagnosis at URF, because I was OK. (So URF says). I am not OK, I am injured, I hear ringing in my ears or buzzing sound. It gets worse, it does not stop. It's worse in quiet settings. I have a harder time hearing people when there is background noise. I do have my doctor report.

Oh yeah, we are close to a year, Policy does say something about medical records after a year. So we need to act kind of fast. I do not want to lose any medical records as evidence! This has also made my mental illness shift to 10 with all the sanctions and harassment. I am getting into that now! After I was thrown to the ground and ticketed for assault and resisting, I lose it. I tried to end my life twice, once I tried to put a Big order my head to suffocate myself. Next I tried to cut my wrist, I don't remember it all, I do know they took video and a C/O named Woodward saved my life and made sure I ate! I do not want to lose any of the evidence. I know it is needed for the case! I don't know what they are afraid to get rid of after a year. But I don't want any of that compromised. Oh yeah, a C/O named Balingier was also of great assistance. I was in observation for 3 days at URF, then went to inpatient treatment.

At a Mental Health Facility. I spent Christmas and New Year's there! I Spent PAGE 5
 30 days in close observation. then I was sent to a Outpatient Program For 3 months. The
 Sanctions From URF Followed me. I was able to JPray and use the Phone when my 30 day
 Break would come. I did not even talk to my family for Christmas or my girl!
 Well not much to tell about WCC or the Program, As I said when I left URF
 I WAS STILL ON Sanctions for months, Just as I am Now. I Left URF
 this time on October 4, 2017. I have Pending Sanctions till December 2nd
 Christmas eve! Me and my girl are talking a little, I hope she hangs
 in there, I do love her. Shes all I got. Ok, anyway's we are not
 done just yet. I told you I am not perfect, I got into a fight
 at the Mental health Program. They cut me lose from the Program. I do
 Not know IF It was the Fight or they figured It was time to go. I tried to ask
 a few different people, never got a clear answer. Let's just say it's the fight
 so I can take the Blame if it is there! I don't want anything to come
 up and Be like, Oh you Lied or hid the truth. I have nothing to hide
 If am not the investigated in this case. I have Been on that side eno!
 I hope to be done with Being the investigated. So after the Program
 year that is where we are. Guesses were they sent me? you guessed!
 Right Back to URF! I WAS like for real, I thought the Nightmare was over. I was go
 to go into this with a Positive outlook, I tried to say "well Maybe I did this". It was this
 way, It will be better; they were teaching me a lesson! Sergeant Davidson was doing
 intake with some New C/O's who were training. I approached him and said I
 was sorry, could we start fresh? He was like, Sure we can start fresh
 He was spreading the Rumors right there. Pointing and Laughing all the
 same stuff as before. I knew right there that things were not going too
 change, and they did not! The tickets started all over again. I seen Serge
 Davidson in my unit talking to the C/O's. I could just feel the tension. He
 was talking about me, and he knew that I knew. It was Mehan, Bieriers, Greenleaf,
 and Wooder. They were all in the so called bubble, it ~~was~~ is like a little
 fenced in area where they sit at in level 4! I should be Level 1, but
 due doo the heavy tickets being written, my Points are crazy high. It
 will take me about 2 years to get my Points down! They take off 6
 Points every 6 months being ticket free! I am sure the Parole Board
 will have questions as well! Ok so, ~~everytime~~ everytime Sergeant Davidson Seen m
 He would be like Mr. Dallas, how are you doing? He knew how I was doing, getting
 tickets. And more Sanctions! He was just Ridiculing me. Lieutenant
 Watkins, same thing in the crows hall, when are you going to steam-
 boat? telling other C/O's things about me! one day I came into the
 chow hall, he was like "I was just talking about you". It was a
 Lady C/O, I was like "what were you talking about?" "aww Never mind".
 He told me, and told the Lady C/O "this is Mr. Dallas".

on 6/10/17 I received 3 tickets, 1 for being in the Red Box by the PAGE 6
 phone, being on the phone and insolence. This was a big deal to me, I am
 trying to give the MOST OFFENSIVE OF OFFENCES. There was not more, I
 could write for days, well I am writing for days; But you could read for
 days! So Anyway, on 6/10/17, first off the Red Box is not very Red, very hard
 to see. Next the ticket says I was warned ~~before~~ several times. I was never
 outside, I am on sanctions. I was warned once, the ticket says several times. Next, I
 was trying to call my girl. I was on my first day break in 30 days. I cannot get through, so
 am stressed out already! ~~through the phone~~ ^{The Copendez} ~~calls me~~ calls me
 over to the little yard shack. He says "I am writing you a ticket". I say "for
 what?" He says "you're in the Red Box". I say, "I am sorry, could you
 please just give me a warning?" I won't do it again, I promise, I
 already have enough sanctions, please?" He says "Oh, you're on sanction?
 I am writing you a ticket for being on the phone as well!" I say "I am
 on break". He says "I don't care; you can't use the phone". I lost it, another not so
 perfect moment! I gave him the finger and told him to fuck off, now you have a ticket
 worth writing, I said and walked away! I am now at ECF at OAKS Level 4, I have
 been here a month, I have received a sanction break here. Because I
 have remaining sanctions from URF for 3 months, as I said, sanctions
 follow you. I just got a break, I can use the phone and pay all
 I want with no problem! That is why it's called sanction break. URF
~~does not let~~ ~~you~~ no one use the phone on sanction break. That is not policy, to not
 let a prisoner use the phone on sanction break! 30 days break, is break come on. So I
 got 3 tickets out of place, for being in the Red Box, interference with administrative
 of rules, for using the phone, and insolence! Guess how many days I got
 I got sanctions? Maybe 10 days, NO! 50 more days, 10, 15, 25 days, and
 the 25 was only supposed to be 20. I have kites to prove that I
 got the extra 5 days! I kited and they did not want to hear about it
 they said I was wrong. There was no way to appeal the tickets. By the
 time I appealed it there, the sanctions would be over! Not only the
 but they turned off my phone all the way; without get a N.O.I., a
 Notice of Intent written. There is due process here, write the N.O.I., I ask
 I want an administrative hearing, if yes I prove I was wrong, then tell me how
 long the phone will be off. you can't just turn the phone off ~~and take~~ and take
 away a liberty just because! My phone was off for 4 months. I kite
 the lieutenants; spin, spin, spin. No one knew why, no one would
 turn it on. My phone was off 4 months, we had holidays, you can
 use the phone at URF on a holiday break, but not me, my phone was
 off. My mental health was getting bad again at that point, and I
 was cutting again! C/O Wooder seen my cuts one day in August,
 he said what's

That? I told him it was from working out. He was like PAGE
 Yeah Huh, well stop working out. I was always told D.O.C stood for
 Department of corrections! We need our family, tie's are important. I have been
 to WCC, ARF, and now ECF; with months remaining of sanctions, due to URF on
 Break; I was never denied use of the phone, it was never an issue. My
 phone being turned off for months is just wrong. Without an N.O.I!
 that is just more wrong and unprofessional and a violation of
 Policy and my Due Process Rights. I do have the kites and the
 grievances that did not do a thing! As a matter of fact, the
 grievance ~~also~~ says what they all say; Untimely, how can my
 grievance be untimely when my phone is still off!

1. Harassment over 40 tickets, 11 Months at URF!
2. Beat up by C/O's who threw me to the pavement!
3. I have scarring due to this, above my eye and below!
4. I now have tinnitis, my ear rings all the time!
5. My Mental Health was in overdrive all the time, not to mention
 the suicide attempts and trips to suicide watch, cutting myself,
 and outpatient program. It took to get me fixed up 4 months total!
6. Been on sanctions for atleast 15 months, no leaving a cell
 room, no human contact except for chow hall, get yard 7 days after
 30 days sanctions, to go to yard for 1 hour in the morning!
7. Increased security level to 4, it will take me 2 1/2 years to
 get to a one at least that is being so good, almost impossible!
8. I was on appeal, I do believe all the tickets played a role
 in me get refused, my lawyer sent me a letter that said stay
 ticket free; I have that letter!
9. My phone privileges were taken without due process for
 4 months, my phone was not to be used from 10-2016 till 12-2016; then
 from 4-2017 till 9-2017; that is 9 months with no phone or pay which
 is a email system we have!
10. URF ALSO DENIED ME PROPER MEDICAL TREATMENT. I
 had to weight till I sot to OAKES. To get my medical needs meet, URF keep
 saying your OK, I was not OK I am INJURED. My hearing is messed up
 I was thrown on my head all of my body weight and the force of the
 throw combined was a hard impact. I weigh over 200 L.B By my selfe.

The failure of a *pro se* litigant to keep the court apprised of an address change may be considered cause for dismissal.
