PETITIONING THE COURT

The probation officer believes that the offender has violated the following conditions of supervision:

Violation Number 1

Special Condition: The defendant shall not use/possess any alcoholic beverages.

On or about March 2, 2018, Mr. Hase possessed and used alcohol.

Nature of Noncompliance for Violation 1

On March 2, 2018, at approximately 1:45 AM officers with the Marquette, Michigan, Police Department responded to a report of a suspicious situation involving a female seated in a vehicle with a male subject standing outside. The reporter believed the male was preventing the female subject from leaving.

Officers arrived on the scene and observed the driver's side door of the vehicle was open and the male subject, who was later identified as Mr. Hase, standing along the driver's side of the vehicle. An empty beer can was at his feet. The driver, Renee Bressette, remained in the vehicle. Ms. Bressette was noted to have an injured lower left lip and injured nose. Fresh blood was noted in her hair. Fresh drops of blood were also noted near the rocker panel of the vehicle. She was believed to be highly intoxicated. She refused to identify herself or the male subject. She also refused to provide a phone number or address. She reported her injuries were due to falling on the front of the vehicle and she had injured her lip while at Remillard's Tavern, Marquette. Ms. Bressette agreed to sleep in the vehicle or sleep at a nearby friend's house, but she would not identify the friend or location.

Mr. Hase was interviewed separately. He had abrasions on his forehead and hands. An odor of intoxicants was apparent on his person. He reported he sustained the injuries during a physical altercation with two males, which occurred nearby a short time ago. He also admitted he was consuming alcohol at the same bar as Ms. Bressette. He denied being involved in an altercation with her. He was given a preliminary breath test, which resulted in a reading of a blood alcohol content of .176%. He was able to leave the scene on foot.
